




# Behavioral health patients that are treated at hospitals and facilities are at high risk for injury or death, even when regular patient monitoring checks are in place.

Openings in these areas have special requirements and must minimize the risk of self-harm while maintaining a balance of patient security and safety. Hardware on these openings should also be able to withstand the extra abuse that can occur at times in behavioral health settings. Schlage's antiligature mortise locks combined with Ives anti-ligature door hinges offer substantial protection.

## Operational requirements:

- No ligature points within areas where patients may cause self-harm
- Highly difficult for patient to remove door hardware and use in dangerous manner
- Bacteria-resistant to prevent spread of germs that contribute to hospital-acquired infections
